9. New Business-

 a. Regional Drainage – Receive staff update and provide direction (ACTION)

Ms. Huff stated that the Final Technical Memo from MBK was received on November 18th and was provided to West Yost, City of Dixon and SCWA staff members. She also mentioned the Dixon Innovation Center (Buzz Oates) project is moving forward with 100% retention basin until a regional solution is available. The drainage plan was reviewed by MBK. Dixon RCD's comment letter reiterated that the regional solution that has been proposed in the Campus Plan (Dixon 257) Project has not been agreed to by the District. Ms. Huff also mentioned that she met with Alex Rabidoux and Gustavo Cruz from SCWA to talk about multibenefit projects in the Upper Tremont 3 and Tremont 1 Watersheds. In addition at a recent "Wheeling Workshop" SCWA staff, consultants and Putah Creek pumpers discussed the potential to utilize Tremont 1 east of Old Davis Road as conveyance for irrigation water that is "wheeled" through Yolo Flood Control & Water Conservation District and/or Mace Ranch Irrigation System, with the potential to make improvements to the drainage system. The board had questions on how this concept would work and would like to have a better understanding. Director Viguie mentioned if our system is going to be used as a conveyance, we should be at the front end of this conversation. Ms. Huff said she would reach out to SCWA and bring it back for a committee or 2 by 2 meeting discussion.

Lastly, Kelly explained with Kevin from Solano RCD and Jay from SCWA's help they were able to install a flow measuring device in the outlet side of the culvert though the railroad at the north end of T3. She displayed the website, through SCWA, which tracks the flow measurements and explained that calibration is still needed. The board thought this was great and requested an additional measuring device(s) be installed for T3 in different locations. The board discussed different sites where it might be best for flow monitoring. Before deciding if one or two devices should be put in, the locations need to be talked over with Jay from SCWA and ask for permission from Campbell soup.

A motion was made by Director Bei, seconded by Director Viguie, to contact SCWA about Tremont 1 plans and get more measuring devices in at Tremont 3. The motion passed as follows:
